Directions for Use

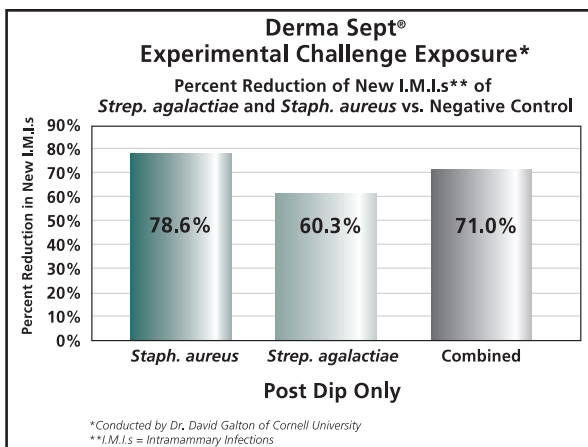
Use at full strength. Do not dilute.

Post Dipping: Immediately after milking, dip each teat with Derma Sept. Allow teats to air dry. Do not wipe. At the end of lactation, apply this product daily for one week after the last milking. In addition, begin application of this product about one week prior to calving.

If a common teat dip cup is used for application, a fresh solution should always be used at each milking. The teat dip cup should be emptied, cleaned and rinsed with potable water after each milking session or when cup becomes contaminated during milking. Do not pour remaining solution from dip cup back into original container.

Research

Derma Sept Sanitizing Teat Dip Conditioner/Winter Teat Dip has been shown in an Experimental Challenge study (performed at Cornell University using procedures outlined by the NMC) to reduce new intramammary infections by an average of 71.0% versus no teat dipping. Derma Sept was also highly effective in several field trials across the United States.
